AAC Members were asked to share their thoughts:

- This exercise was helpful and gave a better understanding of the process.
- Moving students westward to take advantage of capacity is a good idea.
- A more comprehensive redistricting that balances capacity for a lengthier timeframe would be better than redistricting more often.
- It would be better to look further ahead when making redistricting plans, rather than focusing on the immediate future.
- Keep the overall picture in mind, making more comprehensive moves now and make fewer changes later.

- We really need to redistrict more students westward to do the right thing for the county and the BOE.
- More time is needed to review the moves suggested in the above plans and review other possibilities to make better plans.
- It is getting easier to work on the plans, but we still need to remember the impact on the community.
- Consider transportation issues, which are different at the elementary level.
- Develop strategic direction.

Homework

Staff will review the plans, create maps with plan details, determine if plans would work together and plan to speak about planned capital projects in a future meeting.
