- AAC_F plan reports: As of 7/26/11, plan AAC_F moves 1550 students, approximately 6.9% of the countywide elementary population. This plan was not completed, and is still a work-in-progress. Reports included the capacity utilization charts based on the FY12 capital budget as well as capacity utilization without the Gorman Crossing ES addition. Below is a list of the sending and receiving schools, with the numbers of students moved as of 7/26/11.

Presentation

Citizen Plan – A citizen proposed changes to the 2013 staff plan.

- The 2013 staff plan proposed redistricting of an island (polygons 59, 1059, 2059, 3059) from Talbott Springs ES to Stevens Forest ES.
- The citizen proposed not redistricting this island and instead redistricting the other island to Stevens Forest ES (polygons 51, 52, 205, 279, 1051).
- Polygons 51, 52, 205, 279, 1051 would be bused to any school.
- This change seems feasible in terms of capacity utilization and transportation.

AAC Member Plan – An AAC member proposed changes to the 2012 AAC_F plan.

- The plan relieves Fulton ES and Swansfield ES, and takes advantage of capacity at Clarksville ES.
- The plan reduces the number of students moved from Gorman Crossing ES to Fulton ES
- The plan adds the following:
 - Dayton Oaks ES and relieves Fulton ES and Pointers Run ES
 - Pointers Run ES relieves Fulton ES
 - Clemens Crossing ES and Longfellow ES relieve Swansfield ES
 - Clarksville ES relieves Longfellow ES

Specific Questions were addressed regarding several topics:

- One AAC member asked about the remainder of the AAC timeline. We can meet through the end of August if needed. We will finish the discussion on the 2012 plans, then discuss the 2013 staff plan.
- The group discussed open enrollment.
- Remember that small feeds can be resolved through redistricting at either
