This plan was not completed, and is still a work-in-progress. Reports included the polygons moved, capacity utilization charts based on the FY12 capital budget, feeder reports, assessment summary charts and maps. - Goal – bring capacity utilization of southeastern schools within acceptable range by using capacity in the west.

As of 8/16/11, plan AAC_I moves 2348 students, approximately 10.5% of the countywide elementary school population. This plan was not completed, and is still a work-in-progress. This plan also delays the need for the Gorman Crossing ES addition for one year.

The AAC considered many concerns, including the potential to redistrict walkers, the distance traveled to school, and potential to move communities that are quite close to schools.
