To the Members of the Board of Education:

We are writing to express our concerns over the proposed Elementary School Redistricting plans for Polygons 160, 162, 1160, 1162. As parents with several children impacted by this proposed redistricting, we have numerous reservations about the proposal as laid forth in the 2011 Feasibility Study.

Children located in the above specified polygons were subject to a redistricting implemented in 2007. At the time, moving these polygons from Waverly Elementary School to St. John's Lane Elementary School was to address a "bad feed" for Waverly ES. With the shift of these polygons to St. John's Lane ES, a 100% feed was then created. If these polygons are shifted back to Waverly ES, this re-introduces a small "bad" feed back in to the system. Not only would the St. John's Lane ES/Patapsco MS/Mt. Hebron HS 100% feed be impacted, but so would the currently standing 100% feed for Waverly ES/Mt. View MS/Marriott's Ridge HS. This polygon move would be "breaking" a sound system that works well for the schools and the communities involved. Furthermore, we are concerned with the frequency at which these polygons are being redistricted, i.e. 6 years after the previous redistricting. It is not ideal to have the same portions of the neighborhoods, often affecting children within the same families, subjected to multiple redistrictings.

Additionally, it appears as if the number of students that would be moved by this proposal is too small to realistically justify and may be considerably smaller than projected in the Feasibility Study. For example, a total of 11 children of the currently enrolled First Grade students would be moved at the start of their Third Grade year (2013). If this is representative of the community demographics, this would only be a total of 66 students that would be moved to Waverly ES, well below the projected 107 from the Feasibility Study. On our stretch of Old Mill Road, polygon 1162, a total of 8 students across grades K-3 would be moved to Waverly ES. Old Mill Road lies within a large polygon which indicates that the actual number of students impacted may be even lower than projected.

The original move of these polygons in to the St. John's Lane Elementary created a contiguous attendance area that has fostered a Community School serving Elementary,

Middle, and High School. This allows for continuity within grade levels are maintained, as well as continuity between lower and upper grades. This serves both the schools and the students well. Furthermore, solid and sound transitional communications exist between the St. John's Lane ES and Patapsco MS staff, as well as between the Waverly ES and Mount View MS staff. This network does not exist between Waverly ES and Patapsco MS, placing a further burden on teachers at the Middle School level during grade transitions.

We urge the Board of Education to reconsider the proposed Elementary and Middle School Redistricting planned for these polygons, explore alternative solutions that will address the needs for Veteran's Elementary School, e.g. utilizing capacity at Northfield Elementary School, and do further research to vet the numbers used in the Feasibility Study.

Dear Joel,

We are the representatives of the Glenmont neighborhood (polygons 65, 1065, and 2065) who discussed with you the proposed redistricting of our neighborhood from Ellicott Mills MS to Oakland Mills MS and the problems that plan creates. We hope that you remember meeting with us in December 2011 and April 2012.

In reviewing the 2012 Feasibility Study last week, we were very disappointed to see that the recommendation is still to send Glenmont to OMMS and even more troubled to learn that the proposal is now to redistrict us in 2014, not 2015.

When we met with you on April 11th, we offered two alternative scenarios: one kept our neighborhood at EMMS, while the other placed us at Bonnie Branch MS; both allowed Glenmont to remain with high feeds to Howard High. During our meeting, you promised to contact us by the end of the following week (April 20) regarding a more comprehensive analysis of the scenarios. However, although we reminded you on April 30th, we never heard back from you or your office. During our meeting you also stated that, if the 2012 Feasibility Study proposes sending Glenmont to OMMS, you would provide notes about Glenmont in the text, knowing that we would be watching closely.

In the absence of the comprehensive analysis and the notes in the text, we would be grateful for an explanation as to why the 2012 Feasibility Study does not address our concerns:

- (1) If Glenmont students are redistricted to OMMS, they would be the only students who feed to Howard High, creating an unacceptably small feed to Howard High; and
- (2) Glenmont students should remain at Howard High since they are walkers.

We hope to receive a response from your office.

Hi Joel,

Thank you for taking the time to talk to me today about the 2013 elementary school redistricting. I appreciate your willingness to listen to my concerns and suggestions.

My oldest son is going to start kindergarten this August at Ilchester Elementary. According to the feasibility study our polygon (2085) would be redistricted to Rockburn Elementary in 2013. As of the 2013 school year there will ONLY be 3 children from our polygon attending elementary school.

I am also including my neighbor, Maureen Sutch, on this email as her son would also be affected by the potential redistricting.

According to Table 2 of the feasibility study:

*186 students will be leaving Ilchester (polygons 95, 1085, 1095, 2085, 2095, 3085) to attend Rockburn

* 213 new students to attend Ilchester (polygon 91 from Rockburn; polygons 74, 2074 from Waterloo; polygons 1094, 2093, 3093, 4093 from Worthington)

My 1st suggestion is to have polygon 91 to continue to attend Rockburn (42 children), & send polygons 74, 2074 to Rockburn rather than Ilchester (59 children). This would account for 101 students.

My 2nd suggestion is then to have all of the proposed polygons (95, 1085, 1095, 2085, 2095, 3085) to REMAIN attending Ilchester. This would account for 186 students.

If all of the proposed polygons can not remain at Ilchester, then I suggest a division by neighborhoods. Polygons 95, 1095, & 2095 would then go to Rockburn, along with polygons 74, 2074 as stated above These 5 polygons are all located in the same neighborhood (Montgomery Meadows). Then the remaining polygons, 1085, 2085, & 3085 would remain attending Ilchester. This would also keep all of the neighborhoods off of Kerger attending the same school.

I am dismayed to learn that my family would be affected by the proposed school redistricting in 2013-14. A total of <u>four current Ilchester Elementary students</u> would be affected by this change. This includes my two children who reside on 5376 Kerger Road and two children who reside at 5372 Kerger Rd. Only a few select houses in my community (Dunteachin Estates) are located in Polygon 1085. The rest are in Polygon 85. It would make more sense to me that all of the houses be included in Polygon 85.

Dear Chairwoman French and Ms. Giles,

I am writing to you in regards to the latest Feasibility Study that was recently released. I will be unable to attend tomorrow's BOE meeting, but wanted to send my concerns via email. I am a parent, and PTA President at West Friendship Elementary, and am concerned about the projected redistricting of our students from Mount View Middle School. I have a son who recently finished third grade at WFES, and who will be attending Mount View Middle School in 2014. In reading through the proposed Feasibility Study, I see that our street, along with several other WFES streets/families, is slotted to be redistricted to Glenwood Middle School in 2014. We are located in polygon 232, and will be affected by the middle school shift. I understand the need to reorganize and utilize space so that our children may benefit from the best learning situations; however, because West Friendship is such a small, closely knit school, I am concerned for the children who have built friendships and ties to our small community should they be split apart from one another at such a volatile age. I would request reconsideration for splitting the currently enrolled WFES students when the 2014 middle school adjustments are made. Currently, we have two fourth grade classes for the 2012-13 school year. Since my son enrolled in Kindergarten at WFES, we have only had two classes--roughly 48 children--who have grown up together. Our children have been blessed with small classes that allow them to develop strong bonds with one another. Middle school brings enough challenges to our children, I would hate to see a handful of students be torn from the small community they have, and put into a totally new environment without a strong support group.

In considering the proposed 2014 middle school changes, I urge you to revaluate the effects of splitting such a small community. Please consider keeping polygons 224, 229, 231, 232, 1229, 1231, and 2229 together at Mount View.

It is not fair to our children to be uprooted from their home school and established network of teachers and friends simply because of poor planning on Howard County's part. Dear Sirs.

I am a parent of childrent ages 7-13. We moved to Howard County because of the school systems Although I understand that adjustments need to be made to alleviate the overcrowding in the at Veterans and fill the Western Schools, the continued impact to the same communities and schools is alarming. I want to understand how some communities are exempt from the proposed changes while others are asorbing much of the impact. It seems like there has to be a more through review of all of the options.

My concern for the pending re-districting for SJLES and Patapsco. I have learned that you have a process that you must go through to consider all the variables, but I urge you to re-examine some specific areas impaced by your plan.

Have you taken into account the frequency with which students are redistricted and the benefits of a 100% feed. Polygons 160, 162, 1160, 1162 now attending SJLES just went through a major re-districting in 2007. The result of this redistricting was positive because it resulted in a 100% feed to Patapsco and Mt Hebron and although the communities were impacted a strong community has resulted.

- The presence of feeder patterns is important to the strength of the school community.
- What is the impact on the number of students bused and the distance bused? In order to send these proposed Polygons to from SJLES & Patapsco to Waverly & Mt. View, there will be more busses on the roads of Mt. Hebron at the same time that you have walkers going to Hebron.
- The Middle School children being sent to Mt. View will have to be on board the bus three times longer than if staying at Patapsco.
- Cost, It will cost a lot more to bus students from the Mt. Hebron area to Mt. View Middle.

If I understand correctly, one of your goals is to ensure building utilization of between 90- 110 percent where possible. St. Johns Lane is near capacity in the current utilization and operating in a 100% feed to Mt. Hebron. Why are you looking to undo all of benefits gained in 2007. Have you considered looking at other options?

Below are some other possibilities that would help to feed Waverly Mt. View and the Western Schools and relieve overcrowding at Veterans. These options may also allow some other communities the positive impact of a pure feed to their High School.

- Moving Polygons 1164 and 164 to go to the under utilized Waverly (these polygons are currently go to Manor Woods, then Burleigh Manor for MS and onto Marriott's Ridge for HS, so moving to a Waverly, Mt. View and MRHS for them would make a lot of sense and provide these communities with shortened bussing and result in 100% feed.
- From the propsoal on the Web site, I see no current plans for Burleigh Manor to be impacted at all in the Middle School redistricting. Can't they alleviate some of their capacity to send polygons on 1165 and 164 onto Mt. View in 2013 to help alleviate the capacity at Dunloggin? It would seem logical from a transportation and geographical perspective to look at sending Polygons 1164, 164 from Burligh as part of the answer allowing them to asorb some of Dunloggin? . .

Has anyone looked at sending specific polygons from Veterans to Northfield, instead of SJLES (both Worthington and Northfield Elementary don't appear to be near capacity and could absorb some polygons near their schools) this would relieve the overcrowding at Veterans and without having to impact and move students out of SJLES to absorb the majority of the Veterans transfers.

- According to the 2012 capacities, Northfield Elementary School has a capacity of 672 and is operating at 89% in 2012-2013.
- In the 2013 planning map Northfield is not slated to receive any children from the proposed re-districting despite operating below capacity. However given geographical location they are in an ideal and logical location to absorb some polygons from Veterans. Instead of moving 106, or 1106 to SJLES, perhaps Northfield can take other Polygons like. 1103 or 1191, or 191 that are located on the same side of Rt 40 as Northfield.
- Manor Woods is operating at over 100% so moving polygons 1165 and 165 to Waverly would assist in the capacity at Manor Woods, feed under capacity Waverly

Middle School alternatives?

- What is the purpose of Dunloggin MS sending Patapsco 105, 106, 1105, 2308 1308 1106.
 All of the slated polygons except for 106 and 1106 are on the other side of Route 40 from Patapsco and are a a logical feed to Dunloggin.
- Having to absorb all 5 of these polygons will require Patapsco the move a large number of the Children in 160, 161, 162, 1160, 1161,1162, 2161 n currently on 100% feed for Hebron to Mount View. They are not geographically close to Mt. View are slated to retrun to Hebron as walkers when they reach high school just 1-2 years after re-districting. This is yet another example of an unnecessary disruption of the 100% feed that was successfully established in 2007.
- Can Ellicott Mills take any of the proposed Dunloogin students in the Middle School relocation?

Overall, it seems like there has to be a more through review of all of the options. Several petitions and parent surveys have been completed and the plea from the SJLES and Patapsco community is strong. I hope that you will please give all of these options a second review.



A SPECIFIC PLAN FOR CONSIDERATION:

Relieve Swansfield ES's capacity of 114.6% (the projection for 2013-14) by redistricting students to Longfellow ES, and, in turn, redistricting students from Longfellow ES to Clarksville ES (which has a projected capacity of 73.8% in 2013-14).

WHAT ALTERNATIVE CAN YOU OFFER THE COMMITTEE CONCERNING ANYTHING YOU DISAGREE WITH:

I disagree with the recommendation in the Feasibility Study not to include Swansfield ES in this year's redistricting. I understand that this year's redistricting is ambitious and will involve many students (due in large part to the opening of new elementary school #41), but Swansfield ES seems glaringly omitted and the projections continue to be very high for the coming years (2014-15: 113.3%, 2015-16: 114.0%, 2016-17: 114.2%; 2017-18: 115.2%; 2018-19: 116.1%).

During the Board of Education (BOE) meeting on June 14, 2012, one of the BOE members, Dr. Janet Siddiqui, specifically asked Mr. Gallihue about Swansfield ES and Clarksville ES and said that she would like the AAC "... to consider Columbia West again..." "...in particular if you look at Swansfield over those years..." and "...Clarksville elementary school hovering around fifty percent for the projected next ten years..." She stated that she "want[s] the committee to really give that some consideration."


GENERAL COMMENTS:

I live in Polygon 1175. My community's assigned elementary school is Longfellow ES. When my husband and I bought our home during school year 2003-2004, my community's assigned elementary school was Clarksville ES. It was changed to Longfellow ES for school year 2004-2005. I was told by various people (unrelated to the HCPSS) that redistricting happens all the time and we would be switched back at some point. However, it's been eight years. I understand changes are not made unless deemed necessary due to student enrollment projections, but last year one of the members in a nearby community (Marc Steingesser) realized that Swansfield ES was over its capacity and could be relieved by moving students to Longfellow ES, and Longfellow ES students to under-utilized Clarksville ES (for my community, as stated above, "back" to Clarksville ES). This proposal received over 240 letters of support and favorable testimony at BOE public hearings. No one testified in opposition to it. However, it was not adopted last year.

Please take the time to give this request its due consideration this year. If you look at the numbers, you will see that it makes sense for the elementary schools affected. (See below for a comparison of Swansfield ES and Clarksville ES projected utilization percentages taken from the Post-Measures table of the Feasibility Study.) Thank you.

Title: Boundary Lines for Polygon 85: CLC



Dear Howard County Board of Education and the Attendance Area Committee:

We would like to bring our concerns around the boundary lines of Polygon 85 to your attention.

The boundary lines between Polygons 85, 1085 and 3085 effectively isolate 13 homes from the Dunteachin Community. Under the current 2012 Feasibility Study 11 homes (representing a total of 4 elementary students) will be redistricted to Rockburn Elementary with Polygon 1085 and 2 homes (representing 2 elementary students) will also be redistricted to Rockburn Elementary with Polygon 3085. The majority of the Dunteachin Community would remain at Ilchester Elementary.

We would like to discuss with the planning team for HCPSS, the impact of redrawing the boundary lines for 85 to include the homes on the North side of Kerger Rd into Polygon 85. Homes include: 5348, 5352, 5356, 5360, 5364, 5368, 5372, 5376, 5380, 5384, 5388, 5402, 5406.

This move would result in 2 elementary children moving from 3085 into 85 and 4 children moving from 1085 to 85, with a total of 6 children being added into 85.

The goal of the move will be to maintain the community, as HCPSS has stated is one of its goals in developing redistricting plans. The move should not impact the ability HCPSS to meet its overall goals in the 2013 redistricting plan.

We would appreciate this topic being discussed at the Attendance Area Committee meeting on July 3. We would also appreciate the chance to meet with Joel Gallihue and the HCPSS planning team to share data and requirements, and to evaluate the feasibility of our proposal.

Mr. Gallihue - could you please respond and let us know of your availability for the week of July 9? Additionally, due to Friday's storm, can you please confirm if the July 3 meeting is still scheduled to take place?

We appreciate your time and attention and look forward to discussing our proposal.

We are currently in Polygon 85 and it is being proposed that our home, along with 9 other homes in Dunteachin Estates (a 119 home neighborhood) are being moved from our current neighborhood Polygon 85 to Polygon 1085. Two other homes in our neighborhood are being moved from Polygon 85 to Polygon 3085. Even though I do not have a child in elementary school, I do have a 6th grader and a 10th grader that both attended Ilchester Elementary School and could be affected in future middle and high school redistricting. I feel it is very important that we remain in our current polygon. Thank you for your suggestions. We typically review comments with the committee. You are welcome to observe the meetings. We have reviewed your letter and offer the following thoughts:

1 "Have you taken into account the frequency with which students are redistricted and the benefits of a 100% feed. Polygons 160, 162, 1160, 1162 now attending SJLES just went through a major redistricting in 2007."

Policy 6010 identifies a number of factors that will be considered in the development of a plan including, "...make every attempt to not move a student more than once at any organization level or the same student more frequently than once every five years." The proposed redistricting would not move a student that went through the redistricting in 2007. Even the kindergartners who started in 2007, who started at the new school assignments, will have risen to the next level in August 2013 as sixth graders in middle school.

2 Proposes a plan moving 1164 and 164 to Waverly ES from Manor Woods ES. Don't move 106 and 1106 from St. John's Lane ES. Send 1103, 1191, or 191 to Northfield.

Making these changes to the staff plan will result in overcrowding at Northfield. If an entirely new plan were made that did not bring Thunder Hill neighborhoods into Northfield it may be possible. This plan makes it harder to use western capacity. The committee will test scenarios that seek to move less students. Perhaps these suggestions can be incorporated into a viable scenarios.

3 These plans would eliminate a 100% feed to Mt. Hebron.

Assuming the middle school redistricting is approved next year, this may be true. While 100% feed may seem to be a good thing it is not easy to accomplish equitably for all. Policy 6010 anticipates feeds of less than 100% but expects plans to, "[avoid] the establishment of feeds less than 15% where possible." Feeds are but one consideration among many others, including capacity utilization.

4 These plans would increase bus costs.

Pupil Transportation staff evaluated the plans. The aspects of the plan associated with St. John's Lane and Veterans ES were found to be comparable in cost to current bus assignments.

Dear Sirs,

I am a parent of childrent ages 7-13. We moved to Howard County because of the school systems. Although I understand that adjustments need to be made to alleviate the overcrowding in the at Veterans and fill the Western Schools, the continued impact to the same communities and schools is alarming. I want to understand how some communities are exempt from the proposed changes while others are asorbing much of the impact. It seems like there has to be a more through review of all of the options.

My concern for the pending re-districting for SJLES and Patapsco. I have learned that you have a process that you must go through to consider all the variables, but I urge you to re-examine some specific areas impaced by your plan.

Have you taken into account the frequency with which students are redistricted and the benefits of a 100% feed. Polygons 160, 162, 1160, 1162 now attending SJLES just went through a major re-districting in 2007. The result of this redistricting was positive because it resulted in a 100% feed to Patapsco and Mt Hebron and although the communities were impacted a strong community has resulted.

- The presence of feeder patterns is important to the strength of the school community.
- What is the impact on the number of students bused and the distance bused? In order to send these proposed Polygons to from SJLES & Patapsco to Waverly & Mt. View, there will be more busses on the roads of Mt. Hebron at the same time that you have walkers going to Hebron.
- The Middle School children being sent to Mt. View will have to be on board the bus three times longer than if staying at Patapsco.
- Cost, It will cost a lot more to bus students from the Mt. Hebron area to Mt. View Middle.

If I understand correctly, one of your goals is to ensure building utilization of between 90-110 percent where possible. St. Johns Lane is near capacity in the current utilization and operating in a 100% feed to Mt. Hebron. Why are you looking to undo all of benefits gained in 2007. Have you considered looking at other options?

Below are some other possibilities that would help to feed Waverly Mt. View and the Western Schools and relieve overcrowding at Veterans. These options may also allow some other communities the positive impact of a pure feed to their High School.

- Moving Polygons 1164 and 164 to go to the under utilized Waverly (these polygons are currently go to Manor Woods, then Burleigh Manor for MS and onto Marriott's Ridge for HS, so moving to a Waverly, Mt. View and MRHS for them would make a lot of sense and provide these communities with shortened bussing and result in 100% feed.
- From the propsoal on the Web site, I see no current plans for Burleigh Manor to be impacted at all in the Middle School redistricting. Can't they alleviate some of their

capacity to send polygons on 1165 and 164 onto Mt. View in 2013 to help alleviate the capacity at Dunloggin? It would seem logical from a transportation and geographical perspective to look at sending Polygons 1164, 164 from Burligh as part of the answer allowing them to asorb some of Dunloggin? . .

Has anyone looked at sending specific polygons from Veterans to Northfield, instead of SJLES (both Worthington and Northfield Elementary don't appear to be near capacity and could absorb some polygons near their schools) this would relieve the overcrowding at Veterans and without having to impact and move students out of SJLES to absorb the majority of the Veterans transfers.

- According to the 2012 capacities, Northfield Elementary School has a capacity of 672 and is operating at 89% in 2012-2013.
- In the 2013 planning map Northfield is not slated to receive any children from the proposed re-districting despite operating below capacity. However given geographical location they are in an ideal and logical location to absorb some polygons from Veterans. Instead of moving 106, or 1106 to SJLES, perhaps Northfield can take other Polygons like. 1103 or 1191, or 191 that are located on the same side of Rt 40 as Northfield.
- Manor Woods is operating at over 100% so moving polygons 1165 and 165 to Waverly would assist in the capacity at Manor Woods, feed under capacity Waverly

Middle School alternatives?

- What is the purpose of Dunloggin MS sending Patapsco 105, 106, 1105, 2308 1308 1106.
 All of the slated polygons except for 106 and 1106 are on the other side of Route 40 from Patapsco and are a a logical feed to Dunloggin.
- Having to absorb all 5 of these polygons will require Patapsco the move a large number of the Children in 160, 161, 162, 1160, 1161,1162, 2161 n currently on 100% feed for Hebron to Mount View. They are not geographically close to Mt. View are slated to retrun to Hebron as walkers when they reach high school just 1-2 years after re-districting. This is yet another example of an unnecessary disruption of the 100% feed that was successfully established in 2007.
- Can Ellicott Mills take any of the proposed Dunloogin students in the Middle School relocation?

Overall, it seems like there has to be a more through review of all of the options. Several petitions and parent surveys have been completed and the plea from the SJLES and Patapsco community is strong. I hope that you will please give all of these options a second review.

Hello-- I am writing because the polygon in which I live-- #3085-- is proposed in the Feasibility Study to be switched from Ilchester Elementary to Rockburn Elementary.

I have 3 children. Michael is my oldest, and he just completed 5th grade at Ilchester and will be entering Bonnie Branch in the Fall. My second child is William, and he will be entering 2nd grade at Ilchester in the Fall; and, my youngest-- Jennifer-- will be in her 2nd year in the RECC program at Ilchester in the Fall.

One of my concerns about being redistricted to Rockburn is transportation. I have been to Rockburn for Recreation and Parks programs that weren't available at Ilchester, and the driving takes longer than going to Ilchester. For Ilchester, I can turn right onto Kerger Road, continue on Kerger, turn right onto Ilchester Road, and, when I arrive at Ilchester Elementary, I can turn right into the school entrance. The drive to Ilchester can take as little as 3 minutes. When I drive to Rockburn, I have much more to do. I have to turn left onto Kerger, then turn left from Kerger onto Route 103 without a traffic light, then go to the traffic light where Route 103/Montgomery Road and Meadowridge Road intersect with another street and wait to turn left. I then have to go to the next traffic light and turn left again to continue on Montgomery Road. Once I arrive at Rockburn, I have to turn left again to get into the school entrance with no traffic light. If a school bus were to take my children to Rockburn, it would have to the same or even longer route. My children would have to sit on the bus for two left turns at traffic lights and two left turns that do not have traffic lights.

Just like many people who face the possibility of redistricting, we do not want to leave Ilchester primarily because we believe our children receive an outstanding education there, and we feel we are part of a community there. As an active member of the PTA at llchester, I've made it a priority to help all Ilchester families feel that they are part of a community, too. To face the possibility that my two younger children will be taken from Ilchester and sent to Rockburn (eventually to return to Bonnie Branch Middle, which is right next door to Ilchester and shares parking lots) feels like we are being involuntarily taken out of our community. Please reconsider the proposal and keep polygon 3085 in Ilchester's attendance area.

One of the major reasons we moved here almost four years ago was so that our daughters could attend Illchester Elementary. My children have made wonderful friends in the neighborhood and it seems terribly cruel to have them watch all their friends from the neighborhood go to one school while they have to go to another, simply because they live on an arbitrary boundary line. All of Dunteachin Estates needs to be included in Polygon 85. The beauty of living in a neighborhood is to be with your neighbors. Having the neighborhood's children attend the same school only serves to strengthen a neighborhood and build its sense of community. By dividing a neighborhood up, you are essentially destroying the very essence of its community.

We plan on attending as many of the 2012 Redistricting meetings as possible. In the meantime we have a couple of questions that we need addressed:

Ouestions:

- 1. Why is it necessary to divide up the Dunteachin Estates neighborhood, so that 10% of its residents, i.e. those living on Kerger Road, are forced to go to a different school? This 10% includes only a handful of current and future students (6 to be exact)- we are **not** talking about 20-25 students that may begin to impact a school and its resources.
- 2. Why use a street as a boundary line for redistricting? Why not use neighborhood boundaries? If you want to divide districts using a street that separates two distinct neighborhoods, it is logical that the two sides of the street should follow the majority of their neighborhood.
